# <u>PURPOSE</u>

Consider a request from the Nyabing Progress Association to provide ongoing support for a commercial chiropractic service to the Nyabing town site.

# BACKGROUND

At the Ordinary Council Meeting in May 2013 Council resolved to agree to allow use of the Nyabing Infant Health Clinic Facility on a trial basis to the Nyabing Progress Association and Great Southern Chiropractic Services for the purposes of conducting a monthly chiropractic clinic for a fee of \$20 per half day for a period of three months (Council Resolution 4227).

The Nyabing Progress Association has now written to the Council advising that it has been successful in attracting the Great Southern Chiropractic Services from Katanning to Nyabing. This monthly service to the town this service commenced in March 2014 and as a result of consultation with Great Southern Chiropractic Services, the Nyabing Progress Association is seeking ongoing support from the Council to continue this service in Nyabing.

The letter also states that Great Southern Chiropractic Services operate clinics in surrounding towns with rentals for these being: Ongerup \$60, Jerramungup \$25, Lake Grace \$50 and Gnowangerup \$66.

The worst case scenario would be a small revenue loss from hire charges, but based on current trends in appointments it is anticipated that fluctuations in the number of appointments each month would see revenue balance out overall.

# STRATEGIC IMPLICATIONS

This matter is not dealt with in the Shire of Kent Community Strategic Plan.

#### COMMENT

The Nyabing Progress Association has been successful in attracting Great Southern Chiropractic Services to Nyabing. This move has been a positive one and of benefit to a number of ratepayers who already use the service but who would otherwise need to travel to Katanning to do so. The service has been well supported and feedback has been very positive.

Councils current Schedule of Fees & Charges provides for a half daily rate of hire for the hall of \$66.00 or a low impact charge of \$12.00 per hour. The Infant Health Clinic facility is small by comparison to the hall and as such would be expected to be somewhat less than the full charge of \$66.00 per half day.
