Report for Kent Shire BFAC Meeting October 2022

Bushfire Mitigation

Parks and Wildlife Service completed four of its planned burns last Autumn. These include burns in the Williams and Kondinin/Yilgarn Shires. We also completed burns in Cranbrook and Tammin Shires. Early rain meant we were unable to complete as many burns as planned again.

We completed 145km's of track mtce and 12km's of scrub rolling in Dragon Rocks Nature Reserve in the shires of Kulin and Lake Grace. Were not able to get to burning the scrub rolling so will look at burning next Autumn.


In regard to other mitigation plans this financial year, we are looking at doing some blade up scrub rolling for two blade widths on the boundaries of Silver Wattle Nature Reserve. We will then look at burning these to create a wider break fuel reduced break.

Finally, also looking at retreating a buffer in Lake Magenta Reserve in the Shire of Kent.

Reporting Fires to Parks and Wildlife Service

All fires effecting or threatening Parks and Wildlife Service managed land in the Wheatbelt needs to be reported to the Duty Officer on **9881 9200**. This number is available 7 days a week.

The Wheatbelt Region continues to provide bushfire resources that are available on a roster system throughout the bush fire season including weekends and public holidays.



6.10 COMMUNITY EMERGENCY SERVICES MANAGER

Planning, Coordinating, Delivering Training then post course paperwork. Working on Kent PPC issuing with Jess Browne from the Shire.

7 CESM - WHS Act 2020

Quick reminder we are still in the early days of the WHS Act with more awareness growing, especially with the inquiry called into the agricultural sector.

The Shire of Kent council have graciously given us funds to purchase PPC for the 133 volunteers we have registered. I have been working with Jess Browne to purchase items of PPC and we will distribute once it has come in. I'm not sure it will be ready for the season at this stage. We are planning to provide the state standard of equipment to minimise liability on the Shire. Please stay tuned for order forms and sizing guides. This equipment can only be issued to registered individuals, not a quantity per farm. The PPC/E stays the property of the Shire of Kent and shall be returned when someone leaves the area.

Remember, in the absence of proper gear the minimum requirement is for long sleeves and long pants of a natural fibre blend. Sturdy boots, gloves and a hat.

Training

We have the upcoming Rural Fire Awareness course on the 25th in Pingrup. We have ~30 people registered so far, however there are lots of people from the eastern end of the shire who have not yet responded. We need your help encouraging people to attend. It the same as what we did last year and has been well regarded by most participants.

Comments:

Query: Where will we be purchasing the Full Face respirators, we purchased some and they are on backorder.

Response (Matt): Understood, we have a number of suppliers who should be able to supply, we haven't pinned this down yet,

Discussion was had regarding issuing Fire boots to registered volunteers. The consensus was that Boots shall be issued to Registered members of the Town brigades and Active Fire Control Officers.

Resolution

That it be recommended to Council that the Shire of Kent Administration only purchase fire boots for registered Town Brigade Members and Active Fire Control Officers, at least in the initial roll out phase of issuing PPC.

Discussion Against:

Matt Castaldini (CESM) – All registered volunteers are entitled to receive a full kit of Level 1 PPC as per the state standard, which includes boots. As Council have graciously put up considerable

funds to accelerate the rollout of PPC, the CEO would need to be willing to accept the risk of not supplying boots. (In the case where the Shire has supplied boots and they are not worn, the duty is passed from the Shire to the 'Worker'.) The state backed LGGS system should be supplying the requirements of volunteer PPC without the requirement to access ratepayer funds, disappointingly we do not get the funds required to cover the costs.

Discussion For:

Various; Consensus that the average farmer would not change boots in a fire response situation. It is effectively a waste of ratepayer money to purchase boots.

8.1 NOMINATION OF FIRE CONTROL OFFICERS

Legal Implications

s.38. Local government may appoint bush fire control officer

- (1) A local government may from time to time appoint such persons as it thinks necessary to be its bush fire control officers under and for the purposes of this Act, and of those officers shall subject to section 38A(2) appoint 2 as the Chief Bush Fire Control Officer and the Deputy Chief Bush Fire Control Officer who shall be first and second in seniority of those officers, and subject thereto may determine the respective seniority of the other bush fire control officers appointed by it.
- (2A) The local government shall cause notice of an appointment made under the provisions of subsection (1) to be published at least once in a newspaper circulating in its district.

Reminder: The following officers are authorised under r.38A of the Bush Fire Regulations 1954, to prohibit the or operation of any engines, vehicles, plant or machinery during the prohibited burning times or restricted burning times, or both, where the operation of such machinery is, in the opinion of the officer, likely to cause a bush fire, or would be conducive to the spread of a bush fire:

9 GENERAL BUSINESS

9.1 AFDRS / FDI vs FBI / HVMB

Computer Presentation by Matt on AFDRS.

HVMB at FBI 40, Equivalent to the old FDI32 when the reading were taken correctly. We will likely want to reduce the threshold. I am unsure where you would be comfortable, so we will likely need to wait an see. An expectation of a ban between 35-38 could be likely.

Permits are invalid at High and above, potential limitations in Autumn. HVMB Calculations, new 'app'/ offline website.



Action: Provide notification from the Shire to Land owners/ Managers that there will be less days to burn in Autumn next year so farm practise can be amended to not unnecessarily limit people.

Attention Farming Landowners and Managers,

Following a review of the new Australian Fire Danger Rating System, the Shire of Kent Fire Control Officers have discussed and are concerned that there will be less days in Autumn eligible to burn with a fire permit, resulting in less days to burn windrows or chaff dumps. We understand this can have an impact on farming practise and encourage you to seek further information to make informed decisions prior to harvesting.

Everyone should have received 2x CB5 stickers in their rates, there are more available through the Shire, Pingrup Traders and soon Nyabing Ag as required.


9.3 REGIONAL OPERATIONS ADVISORY COMMITTEE (ROAC)



9.5 Rural Fire Awareness / Sectors

Presentation on Rural Fire Awareness – Matt.

One of the things that was learnt from the Narrogin/Wickepin fire was how the sectorising didn't work as no one changed radio channels.



9.6 Structure / FCO Expectations

Expectation for FCOs is that they are leading the community and other farm responders at incidents. This is by stepping back from direct suppression activities and taking steps to assess where the fire is, where it's going, what's at risk, what are we doing about it.

At an incident we should have an Incident Controller and depending on escalation 2 or more sector commanders.


The plan is to build capability and capacity into you, the local FCO team, to be more self sufficient to more effectively support your community in the response to emergency incidents.

By implementing sectors in fire management we can take some load off of the incident controller to have time to plan and assess what is happening and what to do about it.

Each Sector commander can effectively manage the resources in their sector.

The more we can practise using sectors at smaller incidents, we will be in a much better place to use it instinctively in the unfortunate event of a large fire in our area.


If we don't practise, we cant expect to get better at it.



To help with an effective organisation, we have an operational organisation structure. This can help with administration and coordination of resources and response.

People should ideally not be holding multiple concurrent roles such as Captain and DCBFCO as an example. This structure also gives a pathway for progression, as FCOs can move up to being a Captain/FCO of their brigade, then move to Senior FCO, hopefully on to DCBFCO then CBFCO.

The Captain of the brigade is the contact point for the people registered against that brigade and is the person their members should contact in the first instance for support or queries. The Captain should also be the contact point for coordinating activities or requests for their brigade.



Chain of Command – AIIMS Principles

We can revisit FCO role appointments if required.

I have been approved some months ago by each of the 3 CEOs to go on the State Pre-Formed Level 3 incident Management Team. I will be "on-call" one week in four and may need to drop and go to a state incident if mobilised and we aren't already dealing with a significant incident.
