PURPOSE

For Council to endorse conduct of the 2023 Ordinary Council Election utilising internal resources as opposed to outsourcing to the Western Australian Electoral Commission (WAEC) to facilitate a Postal Election on behalf of Council.

BACKGROUND.

Correspondence was received from the Minister for Local Government concerning arrangements for the upcoming 2023 Ordinary Election, which was subsequently followed with correspondence from the Western Australian Electoral Commission (WAEC), including a cost estimate.

COMMENT

Council has, since 2015, appointed the WAEC to conduct Postal Elections on behalf of Council, which incurs a cost whether an election occurs or if there are sufficient or insufficient nominations and an election is declared at the conclusion of the nomination process, or an Extraordinary Election process is commenced thereafter due to insufficient nominations.

The Chief Executive Officer has significant experience in conducting Elections spanning nearly three decades and the Manager Corporate also has experience in the roles of Deputy Returning Officer and Polling Officer.

It is proposed to conduct the 2023 Election in-house and appointing the Manager Corporate as Council's Returning Officer and the Governance Officer, Deputy Returning Officer.

This will provide both staff members with exposure in relation to the process, with oversight and support from the Chief Executive Officer as required.

There are clear trigger-points during the 56-day election process, which Council would have to manage and facilitate regardless if the election was outsourced or conducted in-house.

Further, the estimated cost to conduct the election utilising the Western Australian Electoral Commission is \$13,000.

By contrast, the estimated additional cost to Council to conduct an election which incorporated postal voting, early voting and in-person voting (8am – 6pm Saturday 21 October) amount to \$1,275 plus \$235 associated on-costs, printing and stationery. A total outlay of \$1,510.

This incorporates the following rostering where candidate nominations exceed available vacancies and an election is declared:

\triangleright	Returning Officer	12 hours (07:30 – 19:30)
\succ	Deputy Returning Officer	12 hours (07:30 – 19:30)
\succ	Polling Clerk	2 hours (17:30 – 19:30)
\succ	Polling Clerk	2 hours (17:30 – 19:30)

There is no requirement to engage a Presiding Officer due to the minimal size of responsible officers / Polling Clerks engaged and the direct supervision by the Deputy Returning Officer.

If there is no election, there is no cost with the in-house option.

PURPOSE

Council endorse and authorise preparation of a comprehensive report in relation to work undertaken in response to the Local Government Advisory Board (LGAB) pathway toward the 2023 Ordinary Election.

BACKGROUND.

Council received the resignation of Cr Tapscott in December with an effective date of 1 February 2023.

Council is required, post this effective date, to resolve acceptance of the resignation and make a request to the WA Electoral Commissioner that the vacancy remain unfilled until October 2023 (noting Cr Tapscott's original term concludes October 2025).

COMMENT

Attached is a position paper from Conway Highbury which details the process Council is to follow.

3. Subject to the discussions with LG Advisory Board staff, the Special Meeting also consider-

(a) formally consider the outcomes of the public consultation regarding representation,

(b) determine the basis for a submission to the LG Advisory Board, and

(c) request and extension until 31 March 2023 from the LG Advisory Board to make a submission regarding the voluntary pathway to be taken for a reduction of number of elected members.

4. Subject to the discussions with LG Advisory Board staff, that at the Ordinary Meeting to be held on 15 March 2023, Council consider that the submission to the LG Advisory Board be -

(a) a reduction of number from 8 to 6 as previously decided,

(b) that the balance of the current vacancy for a term concluding in October 2025 be terminated in October 2023, effectively bringing that intended reduction forward 2 years, and

(c) that the reduction of vacancies from 4 to 3 in October 2023 remain in place.
