## **PURPOSE**

Council to consider an application from the Badgebup Aboriginal Corporation to collect native plant seed from reserve land vested in the Shire of Kent for a period of 12 months.

#### **BACKGROUND**

The following submission was received 21 March 2023 on behalf of the Badgebup Aboriginal Corporation:

I am writing to request authority from the Shire of Kent to collect native seed within the shires of Nyabing and Pingrup boundaries under regulation 60. Seed collecting helps to sustain year-round employment for the Badgebup Rangers. The seed is harvested, cleaned and sold to nurseries to grow seedlings for land-care projects, so everything is returned to country.

Johnny Rodd is our Program Manager Land Enterprises and he currently holds a Regulation 60 licence. I have recorded his licence details on the proforma attached.

#### COMMENT

Collection of native plant seed requests are received annually from organisations such as Department of Parks and Wildlife (DBCA), Greening Australia and Formosa Flora.

Council have previously approved requests allowing permission to collect seed for the Badgebup Aboriginal Corporation for the purpose of enabling planned revegetation programs that will benefit the local area and region.

- (ii) Permission is for a twelve month period, commencing April 2023 and concluding March 2024.
- (iii) This letter allows for collection only by Badgebup Aboriginal Corporation staff members and supervised affiliates.
- (iv) Appropriate hygiene measures will be followed at all times to prevent the spread of plant disease and weeds.
- (v) All care will be taken to avoid the disturbance of fauna habitat.
- (vi) All care will be taken to avoid any disturbance that may lead to soil degradation.
- (vii) A report detailing shire reserves accessed and seed collected be provided once the annual collection period is complete.
